Liv-ex insurance

Option 1: No insurance

Option 2: Standard insurance (default option)

£10 per month policy fee plus 0.015% of average monthly stock value.

Option 3: Premium insurance

£10 per month policy fee plus 0.0225% of average monthly stock value.

A basic example of our premium insurance can be found below.

- 1. Your cellar has an average monthly value* of 1,000,000 GBP. Maximum settlement in the event of a total loss would be up to 1,500,000 GBP.
- 2. In the event of a partial loss i.e. 1,000 GBP according to the Liv-ex market value, there is a 50% uplift, so the claim would be up to 1,500 GBP.

*All valuations are to the Liv-ex market value at the time of incident / loss. In any event the claim would be no greater than the loss suffered. Where a claim is made under the Premium insurance for more than the Liv-ex market value, you will need to provide evidence to justify the increased amount.
